

Rector's Decree No. 161 of 28 August 2023

SUBJECT: Supplement to Annexes B.1, B.2 and B.3 of the Public Competition Notice, for qualifications and examinations, for admission to PhD Courses - 39 CYCLE with administrative headquarters at Universitas Mercatorum.

CONSIDERED	the D.M. of 2 March 2023, n. 117, with which the assignment for the year 2023/2024 has been arranged, to be valid on the PNRR, Mission 4, component 2 " <i>From Research to Enterprise</i> " - investment 3.3 " <i>Introduction of innovative doctorates that meet the needs of innovation in enterprises and promote the recruitment of researchers from enterprises</i> ", of doctoral grants of three years co-financed by enterprises, for the frequency of paths for innovative doctorates;

CONSIDERED	conventions and expressions of interest in co-financing scholarships from PNRR resources, pursuant to D.M. 117/2023, M4C2 - Inv. 3.3, received by <i>New Generation Sensors srl</i> and <i>TIM Spa</i> ;
CONSIDERED	the expressed interest of the co-funding companies of scholarship D.M. 117/2023, involved in the Doctoral Courses as provided for by D.R. n. 135 of 19 July 2023 and their annexes, to accept the recipients of such grants at their premises for a period of study and research up to n. 18 months to be carried out in the 3 years of the course;
CONSIDERED	the new deadline for the above-mentioned notice scheduled for 04 September 2023, 12:00 (Italian time);
DEEMED	to adapt the descriptive sheets of the PhD Courses (Annexes B.1, B.2 and B.3);

ART. 1

1. The number of scholarships foreseen for the PhD Course in "*Big data and artificial intelligence*" (Appendix B.1) is integrated with No. 1 scholarship for the resources of the PNRR, pursuant to D.M. 117/2023, M4C2 - Inv. 3.3, co-financed by *New Generation Sensors srl*.
2. The period of study and research at the Company *Centro servizi universitari per l'educazione sociale e professionale tre punto zero srl* is updated to n. 18 months over the 3 years, according to what was demonstrated by the Company itself, co-funding of the D.M. 117/2023 Scholarship.
3. It is authorized the replacement of the Description Sheet of the PhD Course in "*Big data and artificial intelligence*" (Annex B.1) which is an integral part of the Call for Applications for admission to the Doctorate Courses XXXIX cycle - issued with D.R. n. 135 of 19 July 2023 - providing a total of n. 15 Total places, of which: 12 with scholarship, 3 without scholarship.

1. The period of study and research at the Companies *Argo srl* and *Studio De Iapis - Bonomo srl* is updated to n. 18 months in the 3 years, according to what was demonstrated by the Companies themselves, co-financing the Scholarship D.M. 117/2023.

It is authorized the replacement of the Description Sheet of the PhD Course in "*Sustainability and Agenda ESG*" (Annex B.3) which is an integral part of the Call for Applications for admission to the Doctorate Courses XXXIX cycle - issued with D.R. n. 135 of 19 July 2023 - providing a total of n. 15 Total places, of which: 12 with scholarship, 3 without scholarship.
